Mike Bloomberg Unveils New Housing and Earned Income Tax Credit Proposals in California

Proposals Address Housing Affordability and Initiatives to Raise Low-Wage Incomes

Stockton, California—December 11, 2019 - Democratic presidential candidate Mike Bloomberg traveled to California on Wednesday to unveil two new proposals designed to help address affordability and create economic opportunity for all Americans. The proposals, which were released following a roundtable discussion in Stockton, CA hosted by Mayor Michael Tubbs, and featuring Stockton community members, builds on Mike's record as Mayor of New York, where he pioneered programs that helped more New Yorkers gain access to housing and build house wealth.

Mike's housing proposals address the nation's severe shortage of affordable housing, including an expansion of funding for the Low-Income Housing Tax Credit (LIHTC) that would add hundreds of thousands of units of affordable housing over ten years. The proposal also calls for an increase in federal spending in programs like Public Housing Capital Fund, the HOME program, Community Development Block Grants. In addition, the proposal sets aside \$10 billion for a competition to reward

municipalities that offer the best solutions to restrictive zoning and other obstacles, as well increasing funding for federal housing vouchers and reforming them.

Mike's proposals to reform the Earned Income Tax Credit (EITC) focus on the need for effective programs to raise the incomes of low-wage workers, encourage economic participation, share the gains of growth more broadly, and do as much as possible to end poverty in work. The proposals call for reforming the EITC to make it much more generous, especially for single childless workers, as well as simplifying the rules so that the credit is easier to administer.

He also proposed a pilot program to expand the EITC benefit to cover family caregiving and other forms of unpaid or ineligible employment, with the goal of making this an integral part of his EITC reform.

Mike calls for the minimum wage to be raised to \$15 an hour by 2025 and then to be indexed to growth in median earnings.

The proposal will also increase the Child Tax Credit to make it fully refundable, and phase it in faster, starting with the first dollar of earnings. The Child Tax Credit currently works alongside the EITC and raises the incomes of almost all working families, but it does too little for the poorest households.

"I'm running for president to reunite and rebuild our country -- because too many Americans are struggling just to get by, and they've been ignored by Washington for too long," said Mike Bloomberg. "The proposals we announced today reflect my determination to wage war on poverty -- a more innovative and effective war, not business-as-usual, and one that engages trailblazing local leaders like Mayor Tubbs."

MIKE'S RECORD

As mayor of New York City, Mike launched an ambitious affordable housing project, opened large swathes of the city to development and worked to ensure that the poorest had the resources to get roofs over their heads.

As mayor, Mike saw discriminatory and predatory practices in action, when the subprime lending boom led to concentrated distress in the city's majority-minority neighborhoods. He launched an early and aggressive response through the Center for New York City Neighborhoods, which provided free advice and legal aid to help thousands of families navigate loan modifications and avoid foreclosure.

Under Mike's New Housing Marketplace Plan, New York City built or preserved more than 170,000 affordable housing units between 2002 and 2013. He rezoned more than 11,000 blocks -- about 40% of the city -- and prioritized housing near transportation and job centers. At a time when the federal

government was cutting back on housing assistance, he created a rental assistance program called Advantage New York, which moved more than 21,000 families out of shelters and into housing.

The Homeless Outreach Population Estimate, an annual homeless census, aimed to better account for and serve unsheltered individuals. In 2013, the census estimated 3,180 unsheltered individuals, down from 4,395 in 2005 -- a 28% decline. Such data has become a federal requirement for cities receiving homeless housing funds.

Mike created 9,000 units of supportive housing under an innovative city-state deal that was by far the largest of its kind in U.S. history. The 2005 agreement -- aimed at reducing chronic homelessness -- included, for the first time, units for youth and families with special needs and other barriers to stability.

Mike also launched the Homebase program in 2004 to mobilize community groups, landlords, tenant associations and other to keep at-risk families out of city shelters and in their own homes. The program achieved a 20% reduction in shelter use for those who participated, won the 2009 HUD Secretary's Opportunity and Empowerment Award and became a model for cities globally.

As mayor, Mike saw discriminatory and predatory practices in action, when the subprime lending boom led to concentrated distress in the city's majority-minority neighborhoods.

Mike launched an early and aggressive response through the Center for New York City Neighborhoods, which provided free advice and legal aid to help thousands of families navigate loan modifications and avoid foreclosure.

As Mayor of New York City, Mike also created Paycheck Plus, a pilot program to supplement the federal EITC (and a third-party study showed it worked). And under his leadership, New York City expanded access to free tax-preparation services, and launched a program to mail pre-filled EITC applications to eligible workers.

**MIKE BLOOMBERG SPEAKS AT A PRESS CONFERENCE
WITH MAYOR MICHAEL TUBBS
STOCKTON, CA
DECEMBER 10, 2019**

Over the years I've had a chance to work with lots of mayors from across the country, and I can tell you: Mayor Tubbs is the real deal.

He has one of the most ambitious urban agendas in all of America – in terms of fighting poverty... improving schools, reducing homelessness... and improving affordability. He thinks big... he's not afraid to take risks... and he's determined to tackle the toughest challenges head-on. That's my kind of mayor – and it's why I'm so honored to have earned his endorsement in this campaign.

Now, a few months ago, President Trump called California “a disgrace” to our country – a disgrace. Just think about that: The President of the United States – the UNITED States – called the biggest state in the Union, with the most diversity and one of the strongest economies, a disgrace.

Well, I have to tell you: That bothers me – not as a Democrat, but as an American. The president is not supposed to be the head of the party – but the head of the whole country. I'm tired of this being a country where we don't talk to each other – and where the president just divides us. We have got to stop pulling people apart and start bringing this country together.

That's why I'm running for president... because we need to defeat Donald Trump and start uniting and rebuilding America.

The fact of the matter is: We cannot afford four more years of President Trump's reckless and unethical actions. He is a dangerous threat to our country, our values, and our national security. And I truly believe that if he wins another term in office, we may never recover from the damage.

Across the country, we are suffering from a lack of national leadership on all the big issues we face, and we see it all across the country.

But I know we can make progress on all of those issues – because we did it in New York! And we can do it for the whole country.

If we can cut murder in half in New York – and we did – we can do it nationally.

If we can cut incarceration by 39 percent in New York – even as it went up in the rest of the country – we can do it nationally.

If we can raise graduation rates in New York by 42 percent – while also raising teacher salaries by 43 percent – we can do it nationally.

And if we can build record amounts of affordable housing in New York, we can do it nationally.

I've always been a problem-solver and a doer – not a talker. And I've never been afraid to take on the tough fights.

I've taken on President Trump and the NRA over gun violence -- and we've won. The organization I co-founded, Every Town for Gun Safety, has won stronger gun laws in states across the country.

I've taken on the president and the biggest polluters over climate change... and I've led an effort that has closed more than half the nation's dirty coal plants.

I've also taken on President Trump and the tobacco industry over e-cigarette use by children. And we are now winning battles, including down the road in San Francisco, against Jewel.

One of the fights that I took on as mayor – and that I've continued to work on through my foundation – is breaking the cycle of poverty.

Today, our campaign is releasing a few of the policies that will make the federal government a full partner for leaders like Mayor Tubbs, in their work to make housing more affordable and to raise incomes.

But before I review some of the details, let me just make this overall point: As president, my job will be to move all Americans ahead, and that includes committing our country to new and innovative ways to combat poverty.

Yes, there needs to be a war on poverty – a more successful one, a more innovative one, and one that engages local leaders like Mayor Tubbs.

Let's start with affordable housing – and let me just put things in perspective. Over the past two decades, while family incomes have stayed flat, the average rent has gone up 50 percent. And earlier this year, the home ownership rate for black families fell to its lowest level since the early 1960s – back when federal housing policy blatantly discriminated against black families.

So this really is a crisis – and the proposals we're releasing today will help address it.

To start: We're going to substantially increase the construction of affordable housing – both through tax credits and direct government spending, just as we did in New York.

We're also going to increase the supply of affordable housing by providing cities with additional funding if they eliminate restrictions on zoning, particularly near transit areas – just as we did in New York.

We're going to increase the number of Section 8 vouchers – and make it easier for people to use them wherever they want to live.

And we're going to increase the supply of supportive housing available to those who are homeless or need services – just as we did in New York.

We'll also expand federal grants to cities that implement effective programs to prevent and reduce homelessness.

In New York, we cut street homelessness by 28 percent, and a pilot program we created to prevent homelessness helped reduce shelter use by 20 percent for participants in the program – and it saved more money than it cost.

Now, while we certainly didn't solve the problem, another program that we created – which provided rental assistance – also showed promise in reducing homelessness, before it lost state funding.

So we know how to make progress on this issue – and we'll do it nationally.

We'll also fund cities that pilot programs that help more families afford a down payment on a home and that help reverse decades of discriminatory housing policies.

At the same time, we'll strengthen enforcement of the Fair Housing Act and fair lending laws – to stop discrimination.

Now, all of those steps will help make housing more affordable and available. But to fight poverty, we also need to do something even more basic: raise incomes. And we should start with the most straightforward change: raising the minimum wage.

That's what we did in New York, and it has since gone up to \$15 – and that's where it should be nationally.

Raising the minimum wage will lift more people out of poverty – but it's not enough. And that's why I'm also proposing a dramatic expansion of the Earned Income Tax Credit.

The existing tax credit helps parents with children at home. But it does almost nothing for those without young children who are struggling to get by. We'll change that – and we'll lower the age of eligibility, so more people can qualify for it, and we'll support pilot programs in cities and states to broaden eligibility to new groups, including work that isn't paid but that's important in our communities and families.

In New York, we helped more people get the tax credits by filling out the application for eligible workers and mailing it to them – so all they have to do is sign and return it.

As president, I'll go even further – by creating automatic enrollment, so people who are eligible actually receive the benefits without having to deal with all the paperwork.

I believe in a simple idea: If you work full-time, you should earn enough to live on – a living wage! There is dignity in every job – and there should be dignity in every paycheck, too.

Now, many people living in poverty struggle to find steady employment – and many of them are raising young children. We have to do more to help them, too – and we will, by increasing the Child Tax Credit... and expanding its eligibility... and making it fully refundable so that it benefits the poorest families.

It's one of the best investments we can make in America's future, because those kids are the leaders of tomorrow!

I've always believed America is at its best when we work together to find meaningful and lasting solutions to the big challenges we face. That's what I'll do in the White House – and I'm honored to have earned Mayor Tubbs' support.

Finally, let me thank you all for coming out and spending a little of your Wednesday with us, and if you know anyone with a new baby, you know what to get them for the holidays!
