To Connie Cochran:

This letter is to request access to records in the possession of the City of Stockton for the purpose of inspection and copying pursuant to the California Public Records Act (Government Code Section 6250 et seq.) and Article I, Section 3 of the California Constitution.

The information that I ask to inspect is as follows:

- Any staff reports, memoranda, emails, or city hotline tips regarding the I Am Ready nonprofit, the Hollywood Cares nonprofit, and their leader David Lee. Including a proposal to award Lee \$1 million via sole source contract.
- Any opinions by the City Attorney's office, other counsel, or city staff regarding the legality of awarding \$1 million through a sole source contract as opposed to a competitive bidding process.
- Any documents on proposals by Lee describing the work he and I Am Ready will do if awarded grant money.
- Any previous city contracts or grants awarded to David Lee, what he did with the money and when, any performance metrics, and any documents regarding Lee's reported failure to repay money he owed the City of Stockton. Also any recent payments he may have made, and any outstanding balance.

If you are unable comply with this request because you believe it is not clear, California Government Code Section 6253.1(a) requires you to (1) Assist me in identifying the records and information that are responsive to my request; (2) Describe the information technology and physical location in which the records exist; and (3) Provide me with suggestions for overcoming any practical basis for denying access to the records or information I am seeking.

Pursuant to Government Code Section 6253(b), I ask that you make the record(s) “promptly available,” for inspection and copying, based on my payment of “fees covering direct costs of duplication, or statutory fee, if applicable.” I believe that no express provisions of law exist that exempt the record(s) from disclosure.

If a portion of the information I have requested is exempt from disclosure by express provisions of law, Government Code Section 6253(a) additionally requires segregation and deletion of that material in order that the remainder of the information may be released. Government Code Section 6253(c) requires notification to me of the reasons for the exemption not later than 10 days from your receipt of this request.

If you do not need to use the full 10 days, please comply at your earliest convenience. Government Code Section 6253(d) prohibits the use of the 10-day period “to delay access ...”





On March 1, 2023 the Stockton City Council was in a closed session meeting to address Executive Management. Through the duration of the meeting it could be seen that Council Member Kim Warmlesley, Michele Padilla and Mayor Kevin Lincoln were engaged in the cell phones receiving messages.

Prior to the meeting I received a message from Motecuzoma Sanchez stating :

Wed, Mar 1 at 2:21 PM

Good afternoon. I'm hoping you do the right thing and help move our city forward.

I did not respond to the text message or engage. My concern with this message was due to a engagement that took place with Sam Fant addressing the upcoming closed session meeting that resulted in Sam holding an envelope of funds that I declined to accept and refused to further the conversation on.

During this closed meeting I felt there were clear violations to the Brown Act because Motecuzoma Sanchez was aware of what was taking place during the meeting and sent the following two text messages:

Wed, Mar 1 at 4:28 PM

Good to go

Ya estuvo homie

Upon the commencement of the closed meeting, a 'NON- Council Member' already knew the conclusion of the meeting.

When I exited the chambers I texted Gurneel Boparai who advised me that he was on his way to Valley Brew. At this time, no one knew where I was going, but when I arrived at Valley Brew approximately 4:40 PM to meet with Gurneel, Motecuzoma rushed in right behind me.

Motecuzoma approached aggressively with his phone up and on record yelling out about the closed session items. Motecuzoma knew too much information about exactly what was said and how the meeting took place for there not to have been a clear violation of the Brown Act. With the amount of information Motecuzoma had been provided by either Mayor Lincoln, Councilmember Warmlesley or Padilla, Motecuzoma began verbally attacking and became physically aggressive in such a quick manner that Frank Gayaldo had to physically restrain him by putting his body between the two of us when I said I "Man, I don't feel safe here man".

The dialog started as: (M = Motecuzoma / B = Brando / A = Action)

M: "Councilmember Villapudua, tell us why you are keeping Harry Black"

M: "Why did you keep the City Manager around? You were the fourth vote!"

B: "Man I don't feel safe with you right now, this ain't right."

A: Frank Gayaldo proceeds to pull Motecuzoma out of Council Members face and Motecuzoma responds

M: "I will wait until 5 to ask you those questions....

M: I am coming after you, watch.

M: You fucked up man, you fucked up man. You are done. I am coming after you....

B: Are you making a threat now.

M: You know it... just see... watch..

A: As time passed, 5PM approached Motecuzoma started with the comments again.

M: You kept that Bitch Ass Harry Black, you were the fourth vote.

M: I am going after you and Xochitl...

M: Watch

B: You are not supposed to know what happened in closed session.

B: Let's go I don't feel safe here.

Since this incident there have been a series of events that have occurred that concern me as a Councilmember and as a citizen. I am concerned that Motecuzoma harassing and threatening actions will become increasingly volatile because he has lost his primary source of employment and had intended to remove the City Manager for his and Sam Fant's personal financial gain, so I believe.

As of yesterday again I was harassed and threatened to support the removal of City Manager and others and should I not do so, that misleading information will be pushed to the media. With my refusal to default to Motecuzoma's threats, the following post appeared supporting the concerns of the Brown Act violations:

Stockton- Harry Black has come under fire yet again. Multiple sources have leaked to 209 Times that Black was once again nearly dismissed from his duties as City Manager in a recent closed door meeting amongst the city council. While the reason remains unconfirmed, sources believe it may have been related to possible problematic conduct. Questions were raised after Black allegedly made inappropriate and vulgar comments about an unnamed female executive official from CAL Water. The incident occurred at a conference earlier this year in Sacramento, in the presence of two City Council members.

According to one of our sources a council member confronted and scolded Black for his derogatory and misogynist comments, prompting an investigation into the incident.

The City Council did in fact hold a closed session meeting on March 1, 2023, to discuss Black. Sources say that Black narrowly avoided being fired, with a 4-3 vote in his favor. This is not the first time that Black's behavior has come under scrutiny. He was forced out from Cincinnati for taking city staff, and asking the city's female solicitor Paula Boggs Muething, to go with him to a "gentleman's club". She declined.

In November 2021, Black was investigated for creating a hostile work environment, and alleged harassment, primarily towards female employees. Sources tell us his job was spared by a 4-3 vote.

Black's alleged repeated misconduct raises questions about the City Council's decision to keep him in his position. This newest incident has sparked outrage among members of the community members who are calling for Black's resignation, citing his track record of inappropriate behavior.

The City Council has not yet made a public statement on the matter, but the incident highlights the need for more accountability and transparency when it comes to the behavior of public officials. We have reached out to the Councilmember believed to have confronted him, but he has so far refused to respond. This is a developing story. #stockton

In addition to these threats, I am being followed. I rarely encountered Motecuzoma in the community or throughout the day, or any of his partners like Sam Fant. Now it seems like I am running into them everywhere and in the most unlikely locations.

Monday 3/13/2023 I picked up my son from Brookside School located at 2962 Brookside Road, Stockton, CA 95219 and Motecuzoma was there. Of all the times that I have picked up my son, not once have I ever seen Motecuzoma at the school, but now I see him on the same day I am being pressured to endorse a candidate and the removal of Executive Management from the City of Stockton. Motecuzoma and his partner Sam Fant are now showing up at various locations that I am located that they have never engaged me at.

With the actions of Motecuzoma Sanchez and his lack of respect, I fear that Motecuzoma Sanchez will continue to harass and ultimately harm me should he actions of harassment, threat, and political extortion not be addressed.
