Dear Council-member Brando Villapudua :

209 Times' investigative team is in the process of gathering and reviewing mountains of testimony, documentary, video and audio evidence that suggests you not only have a disturbing past criminal history, but that you may also be involved in a criminal conspiracy scheme involving the Stockton Unified School District. Is this true Brando?

Prior to being an elected official, have you ever cooperated with law enforcement in return for a lighter criminal sentence? Should those around you now fear that you will once again play "let's make a deal"?

Regarding the Brown Act violations (which quite frankly should be the very least of your worries) you allege the mayor and your council colleagues are guilty of; are you planning on testifying under penalty of perjury that it was not YOU who in fact first bragged to people outside of closed session, "I saved Harry Black's job"?

I want to be as transparent with you as possible. While I still have numerous questions that I would appreciate discussing with you, I already have an overload of verified information that unequivocally demonstrates that you are totally unfit for office. In other words, regardless of what you say or do from here forward, I will be advocating for your removal from office based on the evidence I already have.
