RE: Leotek EC LED Street Lights

Dear Mr. Caluya;

Thank you for meeting last week with me, Patrick Robitaille (Associated Lighting Representatives) and Ruben Rivera (Jam Services). As discussed, Leotek has experienced higher than normal failures on its "EC" family of LED street lights, shipped between January 2013 and May 2017. According to ALR's records, Leotek shipped the City of Stockton three orders (all believed to be supplied by Jam Services):

8/2014	Jam P.O. # 185493	Qty 3080
5/2015	Jam P.O. # 406311	Qty 2108
7/2016	Jam P.O. # 448781	Qty 5300

The failures occur when there is an excessive concentration of dirt accumulation directly above an LED "die", resulting in heat build-up and subsequent melting of the optic. The failure can be identified by a noticeable orange/yellow warm white appearance when lit (as compared to the cooler white 4000K appearance).


We ask that you conduct a sample review of your street lights to identify what percentage may have failed. Be assured all failures are covered by Leotek's warranty (https://leotek.com/wp-content/uploads/gi-product-standard-warranty.pdf), and Leotek will work closely with you to address any problems.





Dear Ms. Almassy;

The purpose of this letter is to follow up on both our February 24, 2018 letter to Pascual Caluya, and our meeting in December. As we discussed in December, we reviewed our project files to determine if there were any unique warranty related items in the contract, and there were none. However, we remain committed to a "win-win" solution that goes well beyond our warranty obligation, and present the following for the city's consideration:

Warranty Obligation Scenario

This scenario reflects Leotek's warranty (which is industry-standard) and legal obligation; the city removes the failed luminaires and sends back to Leotek at their expense. Leotek repairs the luminaire (replacing the LED engine) and sends back to the city for the city to re-install at their expense. (https://leotek.com/wp-content/uploads/Leotek-General-Illumination-Products-Warranty-11-02-18.pdf). While the LED engine would be of a new mechanical and optical design, the power consumption would remain unchanged, as would all other materials such as the power supply, surge protection device, housing etc. The original warranty expiration date would remain unchanged.

Rather than repair the LED engine, Leotek would replace the *entire* luminaire (including those that have not failed) with a new, current generation "Green Cobra" (GC) luminaire. The GC luminaire family is Leotek's most popular and has been in production with the same basic design for nearly 10 years. The GC uses a completely different optical and LED design that is superior to the EC, and importantly is approximately 25% more energy efficient (lumens/watt) than the EC LED engines in the above scenario.

Based on the reduced power consumption, energy savings using the current "H" series is estimated at over \$1,516,119 (\$6,129,186-\$4,613,067) for a 10 year period as compared to the earlier "Warranty Obligation Scenario".

In addition to the substantial energy savings, if the above approach is acceptable, we can outfit the fixtures with a 7-pin ANSI/NEMA photocell receptacle that allows the city to attach "smart" control nodes if desired. Finally, since the date of your original installations, the market has shifted towards reduced (warmer) color temperatures. If interested, we can supply 3000 Kelvin (K) fixtures as compared to your current 4000K. As LED street lighting has improved significantly since your original installation, the benefits to the city with this "early replacement" approach (a common utility term) would be further reduced energy consumption, and a more contemporary solution typical of what cities are now installing. In our opinion the combination of energy savings, and the value provided by an extended warranty, 7-pin receptacle, 3000K, superior optics, and a new fixture designed to last 15+ years more than off-sets the labor costs.

During our conversation you indicated that the city did not have the resources for labor. As labor is not covered in our warranty, an option we propose is to use the services of an "ESCO" (energy services company). ESCO's are commonly used in energy saving related projects because they are a one-stop shop who can specify, manage, install and finance a project based on the energy savings. In the example above, the energy savings of \$1.5M would off-set the labor costs and once covered (estimated at 10 years, which is also the warranty period), the additional annual savings of \$150,612 would accrue to the city.

Leotek has worked closely with Tanko Lighting (San Francisco based), Ameresco, Siemens and they all are qualified to conduct the work. Related, the city may want to entertain a separate project with an

ESCO to replace your remaining conventional 100W HPS fixtures in your residential areas, and finance those over the course of 10 years as well to avoid any upfront costs.

Please review the above with your team and let's regroup to discuss the details of the above proposal to see how it meets your requirements.



City shall not be responsible for damage or loss of scanner or peripherals. City's contractor will use the scanner to record each luminaire barcode and recycle or dispose of the luminaire at a facility chosen by the City's contractor. City will furnish Leotek with the recorded serial numbers and the City's Construction / Demolition Recycling Report.

City does not guarantee the accuracy of the recorded information, and luminaires with missing or defaced barcodes will not be scanned, tracked, or inventoried.


