





Investing in Our Community

Caring for our community outside of the four walls of the hospital is something we are proud to do. Over the past three years, we have invested more than \$213 million in community benefits and amenities.

Some of our investments include:

- Unreimbursed Care: \$163.4 Million
- Expanding Our Provider Network: \$36.7 Million
- Community Health Improvement Services: \$8.6 Million
- Homeless Health Initiative: \$3.6 Million
- Direct Investments for a Healthier Community: \$2.2 Million
- Community Grants: \$1.3 Million

Project Description

The expansion of St. Joseph's Medical Center is proposed in multiple phases and will be designed specifically to meet the health needs of the community while respecting local neighbors.

Analyzing Historic Merit


An extensive, third-party analysis was conducted in late 2021 by an independent consultant as part of the Environmental Impact Report to assess any historical merit.


Although St. Joseph's has an interesting history dating back to 1899, the buildings proposed for demolition at the proposed expansion site do not meet the standard for historic merit.




Due to lack of historical associations, architectural merit and compromised integrity, the current properties do not qualify for local historical designation under any of the following:

- Stockton's Structure of Merit criteria
- Landmark criteria
- The National Register of Historic Places
- The California Historical Resources Information System

Economic Impact

Existing Operations

St. Joseph's Medical Center generates significant economic activity in the city and county, supporting a wide range of jobs each year. This includes Direct (operating revenue and employment), Indirect (business-business transactions), and Induced (employee spending locally) impacts.



\$1.1 Billion annually in economic activity



6,146 Jobs supported



Economic Impact Continued

One Time Construction Impacts

The construction of the proposed expansion will generate a one-time burst of economic activity through construction-related activities.

(Includes Direct, Indirect, and Induced impacts)



\$739.3 Million in total one-time economic output



5,102 Jobs created over an 8-year period



\$369.1 Million in total labor income



Economic Impact continued

Project Completion

Ongoing economic impacts will benefit the local economy on an annual basis upon project completion.

(Includes Direct, Indirect, and Induced impacts)



\$1.6 Billion in economic activity



6,926 Jobs supported



Expanded Physician Residency Program

Our region continues to face a severe physician shortage. Dignity Health is playing a leadership role to help recruit, train, and retain the next generation of primary care and specialty physicians.



In 2022, St. Joseph's Medical Center has:

- 137 medical and surgical residents
- Specialties in Family Medicine, Internal Medicine,
 Emergency Medicine, Psychiatry, Anesthesia, Neurology,
 Urologic Surgery, and Transitional Year

The proposed hospital expansion project will:

- Increase capacity for our growing residency program, with a conservative estimate of 238 residents by Fiscal Year 2027
- Support expansion of residency programs in Orthopedic Surgery and Interventional Radiology
